Function of the Local Traffic Committee

Background

Roads and Maritime Services (RMS) is legislated as the Authority responsible for the control of traffic on all NSW Roads. The RMS has delegated certain aspects of the control of traffic on local roads to councils. To exercise this delegation, councils must establish a local traffic committee and obtain the advice of the RMS and Police. The Inner West Council Local Traffic Committee has been constituted by Council as a result of the delegation granted by the RMS pursuant to Section 50 of the Transport Administration Act 1988.

Role of the Committee

The Local Traffic Committee is primarily a technical review and advisory committee which considers the technical merits of proposals and ensures that current technical guidelines are considered. It provides recommendations to Council on traffic and parking control matters and on the provision of traffic control facilities and prescribed traffic control devices for which Council has delegated authority. These matters are dealt with under **Part A** of the agenda and require Council to consider exercising its delegation.

In addition to its formal role as the Local Traffic Committee, the Committee may also be requested to provide informal traffic engineering advice on traffic matters not requiring Council to exercise its delegated function at that point in time, for example, advice to Council's Development Assessment Section on traffic generating developments. These matters are dealt with under **Part C** of the agenda and are for information or advice only and do not require Council to exercise its delegation.

Committee Delegations

The Local Traffic Committee has no decision-making powers. The Council must refer all traffic related matters to the Local Traffic Committee prior to exercising its delegated functions. Matters related to State Roads or functions that have not been delegated to Council must be referred directly to the RMS or relevant organisation.

The Committee provides recommendations to Council. Should Council wish to act contrary to the advice of the Committee or if that advice is not supported unanimously by the Committee members, then the Police or RMS have an opportunity to appeal to the Regional Traffic Committee.

Committee Membership & Voting

Formal voting membership comprises the following:

- one representative of Council as nominated by Council;
- one representative of the NSW Police from each Local Area Command (LAC) within the LGA, being Newtown, Marrickville, Leichhardt and Ashfield LAC's.
- one representative from the RMS; and
- State Members of Parliament (MP) for the electorates of Summer Hill, Newtown, Heffron, Canterbury, Strathfield and Balmain or their nominees.

Where the Council area is represented by more than one MP or covered by more than one Police LAC, representatives are only permitted to vote on matters which effect their electorate or LAC.

Informal (non-voting) advisors from within Council or external authorities may also attend Committee meetings to provide expert advice.

Committee Chair

Council's representative will chair the meetings.

CONFIRMATION OF MINUTES

The minutes of the Local Traffic Committee meeting held in August 2020 were confirmed.

MATTERS ARISING FROM COUNCIL'S RESOLUTION OF MINUTES

The Local Traffic Committee recommendations of its meeting held in August 2020 were adopted at Council's meeting held on 25 August 2020, subject to the following amendments:

- 1. Not adopting LTC0820 Item 4 Chandos Street, Haberfield Proposed Intersection Modification;
- 2. Note the safety concerns of residents on Chandos Street;
- 3. Note that the IWC Local Area Improvement Strategy (LAIS), relied in the report to the Traffic Committee, was written prior to the opening of the M4 East tunnel. As such it

does not contain current traffic data, and needs to be updated and reviewed prior to any local road closures being implemented;

- 4. Note that Transport for NSW has advised it has received over 3,000 submissions to their proposed changes to local roads in the area and will provide a further consultation report in September 2020;
- 5. Write to Transport NSW to provide an updated traffic study for the area as required by a condition of the opening of the M4 East; fund council to review and implement the IWC LAIS in the light of the traffic study;
- 6. LTC0820 Item 5 Tempe South Draft Local Area Traffic Management (LATM) Study -A further LATM Study be undertaken of the impact of traffic on students at Tempe Public and Tempe High School, and associated streets including Edwin Street and Tramway Street Tempe and the treatments be reviewed in the light of the additional study; and
- 7. LTC0820 Item 10 Traffic in Alt Street, Ashfield Council note that staff will be arranging a pedestrian/traffic volume count to determine if the site meets the warrants for a crossing. The Ashfield Traffic Management Study (ATMS) also recommended the need to calm traffic in Alt Street at this location.

LTC0920 Item 1 Nelson Street, Annandale (At Booth Street) - Proposed Adjustments to traffic line markings and pavement symbols (Gulgadya-Leichhardt Ward/ Balmain Electorate/ Leichhardt PAC)

SUMMARY

Council has finalised a design plan for the proposed adjustments to traffic line markings and pavement symbols at Nelson Street, close to the intersection of Booth Street, Annandale to improve cyclist and pedestrian safety in the area.

Officer's Recommendation

THAT the detailed design plan (Design Plan No.10121) for the proposed adjustments to traffic line markings and pavement symbols at Nelson Street, close to the intersection of Booth Street, Annandale be approved.

LTC0920 Item 2 Kintore Street at Blackwood Avenue, Dulwich Hill – Modifications to existing Raised Pedestrian Crossing - Design Plan 10139 (Djarrawunang - Ashfield Ward / Summer Hill Electorate / Inner West PAC)

SUMMARY

Council has finalised a design plan for pedestrian safety improvement works in Kintore Street at Blackwood Avenue, Dulwich Hill. The proposed works will modify the existing raised pedestrian crossing to improve pedestrian and motorist safety and addresses concerns about pedestrian safety, particularly school children, and driver behaviour in the area.

Officer's Recommendation

THAT the detailed design plan for the modification of the existing raised pedestrian crossing and new adjacent kerb ramps and associated signs and line markings in Kintore Street at Blackwood Avenue, Dulwich Hill (as per Plan No.10139) be APPROVED.

DISCUSSION

The representative for the Member for Summer Hill tabled the following comment from the Member: "I welcome this commitment to modify the existing raised pedestrian crossing to improve pedestrian and motorist safety and addresses concerns about pedestrian safety, particularly school children, and driver behaviour in the area. I strongly support this commitment and note the many times that this was raised in the NSW School Safety Survey that I conducted."

The Committee members agreed with the Officer's recommendation.

LTC0920 Item 3 Un-named lane rear to Charlotte Street, Ashfield - Temporary Full Road Closure (Djarrawunang-Ashfield Ward/ Summer Hill Electorate/ Burwood PAC)

SUMMARY

An application has been received for the temporary full road closure of the un-named lane rear of Charlotte Street, between Elizabeth Street and Station Street, from 12 October 2020 to 13 October 2020, between 7.00am-3.00pm to stand a mobile crane and replace failed air conditioning units to the Club Ashfield, premises No. 1-11 Charlotte Street, Ashfield.

Officer's Recommendation

THAT the proposed temporary full road closure of the rear un-named lane to Charlotte (between Elizabeth Street and Station Street), Ashfield, from Monday 12 October to Tuesday 13 October 2020, between 7.00am-3.00pm for a mobile crane to replace failed air conditioning units to the Club Ashfield be approved; subject to, but not limited to, the following conditions:

- 1. A Road Occupancy License be obtained by the applicant from the Transport Management Centre;
- All affected residents and businesses, including the NSW Police Area Commander, Fire & Rescue NSW and the NSW Ambulance Services be notified in writing, by the applicant, of the proposed temporary full road closure at least 14 days in advance of the closure with the applicant making reasonable provision for stakeholders; and

LTC0920 Item 4 Balmain Road and Marion Street, Leichhardt - Proposed Expanded Bicycle Storage Area (Gulgadga - Leichhardt & Baludarri - Balmain Ward/ Balmain Electorate/ Leichhardt PAC)

SUMMARY

As part of the Cycleway Capital Works Program, Council has prepared a concept design plan for the proposed new expanded bicycle storage area at the intersection of Balmain Road and Marion Street, Leichhardt. The intention of the proposal is to provide a dedicated bicycle lane at this intersection to improve road safety and prevent cyclists from impeding left turning vehicles at the intersection.

Officer's Recommendation

THAT the concept design plan for the proposed expanded bicycle storage area and associated signage and line markings in Balmain Road at the intersection of Marion Street, Leichhardt (as per Plan No. 10120) be APPROVED, subject to TfNSW approval.

DISCUSSION

The Committee members agreed with the Officer's recommendation.

COMMITTEE RECOMMENDATION

THAT the concept design plan for the proposed expanded bicycle storage area and associated signage and line markings in Balmain Road at the intersection of Marion Street, Leichhardt (as per Plan No. 10120) be APPROVED, subject to TfNSW approval.

LTC0920 Item 5 Beattie Street/ Harris Street, Balmain - Proposed Garden Bed/Kerb Extension (Baludarri - Balmain Ward/ Balmain Electorate/ Leichhardt PAC)

SUMMARY

Council has received concerns regarding vehicles causing building damage to No. 197 Beattie Street, Balmain whilst manoeuvring near the corner of Harris Street and Beattie Street, Balmain. This has raised concerns for both the structural integrity of the building and pedestrian safety.

Officer's Recommendation

THAT:

- 1. The proposed garden bed/kerb extension at the intersection of Beattie Street and Harris Street, Balmain be supported;
- 2. That this project be listed for consideration in a forward capital works program; and
- 3. Prior to construction of any physical device, an interim treatment of a painted island and road flaps are provided in lieu of the garden bed/kerb extension.

DISCUSSION

The TfNSW representative asked whether swept paths of the left turning vehicles has been checked. Council Officers confirmed that swept paths were checked and a more detailed line marking plan will be prepared following the meeting.

The Committee members agreed with the Officer's recommendation.

COMMITTEE RECOMMENDATION

- 1. The proposed garden bed/kerb extension at the intersection of Beattie Street and Harris Street, Balmain be supported;

LTC0920 Item 6 Booth Street, Annandale - Proposed Speed Cushion Upgrades and Cycle Lane Improvements (Gulgadya-Leichhardt Ward/Balmain Electorate/Leichhardt PAC)

SUMMARY

Council has prepared a detailed design plan to replace existing speed cushions and formalise the dedicated bicycle lane with associated new kerb blisters in front of No.135 Booth Street, Annandale. The intention of the proposal is to slow traffic and improve road safety for pedestrians, cyclists and motorists at the intersection.

Officer's Recommendation

THAT the design plan (Design Plan No.10143) for the proposed speed cushion upgrades and cycle lane improvements frontage of No.135 Booth Street, Annandale be approved.

DISCUSSION

The Committee members agreed with the Officer's recommendation.

LTC0920 Item 7 Edinburgh Street, Murray Street And Railway Parade, Marrickville – Marrickville Metro Expansion Works – Notice of Further Change of Dates of a Temporary Full Road Closure for a 6 Week Period Now Starting 20 September 2020 – To Undertake Excavation Works for Sewer Connection to Main Line (Midjuburi – Marrickville Ward / Newtown Electorate / Inner West PAC)

SUMMARY

Council has received notice, from MLATP (contractor to Marrickville Metro Shopping Centre expansion works/ADCO), of a further change of dates of the proposed temporary full road closure of parts of Edinburgh Road, Murray Street and Railway Parade, Marrickville for a 6 week period for the purpose of undertaking excavation works for a sewer connection to the main line. It is recommended that the proposed new change of dates for the temporary full road closure be approved, subject to the conditions outlined in this report.

Officer's Recommendation

THAT the proposed temporary full road closure of Edinburgh Street, Murray Street and Railway Parade, Marrickville for a period of 6 weeks from 12 September 2020 to 24 October 2020 (contingency period of one week start date 25 September 2020) be approved for the purpose of sewer connection works relating to Marrickville Metro Expansion works subject to, but not limited to, the following conditions:

- 1. A Road Occupancy License be obtained by the applicant from the Transport Management Centre;
- All affected residents and businesses, including the NSW Police Area Commander, Fire & Rescue NSW and the NSW Ambulance Services be notified in writing, by the applicant, of the proposed temporary full road closure at least 7 days in advance of the closure with the applicant making reasonable provision for stakeholders;
- 3. The occupation of the road carriageway must not occur until the road has been physically closed;
- 4. Subject to written concurrence from Sydney Metro TSE Group and Transit Systems / Sydney Buses is provided to Council;
- 5. Subject to written concurrence from Transport for New South Wales; and
- 6. The temporary removal and reinstatement of any Council assets will be at the applicants cost and to Council satisfaction.

DISCUSSION

The Committee members agreed with the Officer's recommendation.

LTC0920 Item 8 Lilyfield Precinct Parking Study

SUMMARY

The Lilyfield Precinct Parking Study reviewed the location, supply, demand and distribution of short and long stay parking, commercial, residential, employee, and commuter parking. The work consisted of examining existing conditions including parking data, community submissions, observed parking conditions, existing permit allocation, and future land uses within the Lilyfield precinct. A community survey was also undertaken to gauge the parking issues faced by different users. With consideration future sporting events at Leichhardt Oval, a draft parking management strategy for Lilyfield was developed.

Officer's Recommendation

THAT:

- 1. The Draft Lilyfield Precinct Parking Study including the Draft Lilyfield Parking Strategy be endorsed for community consultation; and
- 2. The draft report be placed on Public Exhibition, providing a minimum 28 days for submissions and the results be reported back to the Traffic Committee.

The Committee members agreed with the Officer's recommendation.

LTC0920 Item 9 Balmain East Precinct Parking Study

SUMMARY

The Balmain East Precinct Parking Study reviewed the location, supply, demand and distribution of short and long stay parking, commercial, residential, employee, and commuter parking. The work consisted of examining existing conditions including parking data, community submissions, observed parking conditions, existing permit allocation, and future land uses within the Balmain East precinct. A community survey was also undertaken to gauge the parking issues faced by different users. This led to the development of a draft parking strategy for Balmain East.

Officer's Recommendation

THAT:

- 1. The Draft Balmain East Precinct Parking Study including the Draft Balmain East Parking Strategy be endorsed for community consultation; and
- 2. The draft report be placed on Public Exhibition, providing a minimum 28 days for submissions and the results be reported back to the Traffic Committee.

DISCUSSION

The Committee members agreed with the Officer's recommendation.

COMMITTEE RECOMMENDATION

THAT:

- 1. The Draft Balmain East Precinct Parking Study including the Draft Balmain East Parking Strategy be endorsed for community consultation; and
- 2. The draft report be placed on Public Exhibition, providing a minimum 28 days for submissions and the results be reported back to the Traffic Committee.

LTC0920 Item 10 Wardell Road, Dulwich Hill - Request for extension to existing school drop off zone adjacent to St Maroun's College at Nos.149-206 Wardell Road (Djarrawunang Ward/ Summer Hill Electorate/Inner West PAC)

SUMMARY

Representations have been received from the Principal of St Maroun's College and parents of children attending the school for an extension to the existing school drop off / pick up zone on Wardell Road, Dulwich Hill. The Principal of the school stated that the length of the drop off/pick up zone has been a safety problem for some time. In a discussion with the Principal it was agreed between the parties that the extension of the zone would be to the school boundary (some 10m) which would provide a further 2 spaces for drop off and pick up. It is envisaged that the additional two drop off/pick spaces will reduce the instances of vehicles queuing on Wardell Road in the peak periods thereby improving safety.

It is recommended that the existing 30 metre length of school drop off zone along the southern side of Wardell Road, Dulwich Hill (adjacent to St Maroun's College) be extended by 10 metres (in line with the north-east school boundary line) to cater for the safe drop of and collection of children attending St Maroun's College.

Officer's Recommendation

THAT:

- 1. The existing 'No Parking 8.00am-9.30am; 2.30pm-4.00pm School Days' restrictions adjacent to St Maroun's College on Wardell Road (southern side of roadway) be extended 10 metres eastward (to the school boundary line west of Gilbert Barry Reserve) to improve road safety outside St Maroun's College; and
- 2. Council's Parking Officers be requested to regularly enforce the parking restrictions outside St Maroun's College in Wardell Road, Dulwich Hill during morning and afternoon school peak periods.

DISCUSSION

The Committee members agreed with the Officer's recommendation.

COMMITTEE RECOMMENDATION

THAT:

- 1. The existing 'No Parking 8.00am-9.30am; 2.30pm-4.00pm School Days' restrictions adjacent to St Maroun's College on Wardell Road (southern side of roadway) be extended 10 metres eastward (to the school boundary line west of Gilbert Barry Reserve) to improve road safety outside St Maroun's College; and
- 2. Council's Parking Officers be requested to regularly enforce the parking restrictions outside St Maroun's College in Wardell Road, Dulwich Hill during morning and afternoon school peak periods.

For motion: Unanimous

LTC0920 Item 11 Gordon Crescent, Stanmore - Proposed 'No Parking 7AM-7PM – Motor Vehicles under 4.5t GVM Excepted' restrictions (Damun - Stanmore Ward/ Newtown Electorate/ Inner West PAC)

SUMMARY

Council has received concerns of long-term parking of certain vehicles, including boat and other trailers, oversized vehicles and in some instance's caravans, in Gordon Crescent. Council subsequently proposed 'No Parking 7AM-7PM – Motor Vehicles under 4.5t GVM Excepted' restrictions in an attempt to resolve this matter.

Officer's Recommendation

THAT the following 'No Parking 7AM-7PM – Motor Vehicles under 4.5t GVM Excepted' restrictions along Gordon Crescent, between Stanley Street and Douglas Street be approved:

- A 24-metre 'No Parking 7AM-7PM Motor Vehicles under 4.5t GVM Excepted' section from existing 'No Parking' signage, opposite Property No. 36 to opposite 52A Gordon Crescent, Stanmore;
- A 140-metre 'No Parking 7AM-7PM Motor Vehicles under 4.5t GVM Excepted' section from 12 metres east of above proposed '10P' section, opposite Property No. 52 to the intersection of Gordon Crescent and Bruce Street;
- 3. A 145-metre 'No Parking 7AM-7PM Motor Vehicles under 4.5t GVM Excepted' section beginning from 22 metres east of above proposed '10P' section, to opposite rear of 5 Douglas Street, 12 metre west of existing pram ramp; and
- 4. A 49-metre 'No Parking 7AM-7PM Motor Vehicles under 4.5t GVM Excepted' section beginning east of existing pram ramp to existing car share signage.

DISCUSSION

Council Officers advised that Council has received a petition in support of the proposed restrictions. The petition included 33 signatures from 27 properties. Council Officer stated that the head petitioner advised that both the consulted and modified/recommended proposals are supported by residents, but the proposal as recommended is preferred by the majority of residents.

The Committee members agreed with the Officer's recommendation.

SUMMARY

Council is currently reviewing concerns of long-term parking of certain vehicles along the railway corridor and Terminus Street, Petersham has been identified as a potential problem location. These include boat and other trailers, oversized vehicles and in some instances, caravan. Council is proposing a parking strategy in order to regulate and enforce long-term parking of such vehicles.

Officer's Recommendation

LTC0920 Item 13 Parramatta Road Urban Amenity Improvement Program (PRUAIP) Public Art Program - Norton Street, Leichhardt (Gulgadya -Leichhardt Ward/ Balmain Electorate/ Leichhardt PAC)

SUMMARY

The PRUAIP, is funded by the Department of Planning Infrastructure & Environment (DPI&E) and is a \$198 million initiative to improve open space and active transport links along the Parramatta Road corridor. Six local Councils will be provided funding under the program to deliver 32 projects in and around Parramatta Road. This is part of the government's commitment to revitalisation precincts between the inner west and Parramatta.

A key feature of DPI&E's commitment to revitalisation is the commissioning of public art to activate locations and tell stories of place, and this includes a public art site for Norton Street, Leichhardt. A commissioned artwork currently undergoing design development and critical engineering investigation, will become a key feature of the Norton Street/ Parramatta Road site upgrade. The work is an exciting and significant design proposal; encompassing a suspended light sculpture, strung between uprights which form a custom-made support

structure. The structure will replace the existing flag poles situated at the public art site – and will be situated above the road between Renwick Lane and Parramatta Road, Leichhardt. The engineering for the safe installation of the work is currently underway, and will involve a rigorous three-point certification process, with an additional peer review by a suitably gualified engineer before the work is installed.

The proposal presented reflects the outcomes of a recent concept design stage, including community consultation, and approval to proceed with design development by DPI&E. This report invites early feedback from the Local Traffic Committee, and is presented in advance of a further presentation when the work's design is resolved, and when approval for the Traffic Management Plan for installation of the work is presented. A Development Application for the work will also be submitted as part of the approvals process.

Officer's Recommendation

INDER WEST

THAT committee ENDORSE the design proposal for submission as part of a Development Application, with the understanding that the 100% public art design and TMP be presented for approval prior to the installation of the work.

DISCUSSION

The TfNSW representative did not support the proposal due to the colours and flickering lights used in the artwork and the impact it will have on motorists given its proximity to the traffic signals. The representative stated that TfNSW can give further consideration to this proposal through the DA process. Council Officers noted the representative's concerns and stated that the artwork will potentially be moved away from the traffic signals and this issue will be addressed through the DA.





SUMMARY

Council has finalised a design plan for the proposed construction of speed cushions, reconstruction of existing kerb, gutter and footpath, as well as resurfacing the road in Donnelly Street, Balmain. The works are proposed to improve pedestrian and motorist safety in the area.

RECOMMENDATION

THAT the detailed design plan (Design Plan No.10135_A) for reconstruction of existing kerb, gutter and footpath, resurfacing of road and the proposed speed cushions with line marking in Donnelly Street, Balmain (in front of property Nos. 11 &13) be approved.

BACKGROUND & OTHER STAFF COMMENTS

As part of the 2020/2021 Traffic Facilities (LATM) Capital Works Program, Council is proposing to undertake works on Donnelly Street including the installation of two (2) speed cushions, in front of property Nos. 11 & 13 Donnelly Street, Balmain to achieve appropriate speeds on the approach to the 'blind' corner. At this location, the existing building alignment and road geometry restricts vehicles moving in opposing directions from sighting each other.

The detailed design plan shown in **Attachment 1** outlines the proposed works at Donnelly Street, Balmain and includes the following treatments:

- Installation of two (2) asphalt speed cushions
- Resetting existing sandstone kerb to new levels and constructing new concrete gutters to new levels on both sides of Donnelly Street;
- Reconstruction of existing asphalt footpath;
- Resurfacing the road pavement with new asphalt surface,
- Upgrading two (2) existing stormwater drainage pits; and
- Installing associated pavement line marking and signage as required.

The proposal will not result in the loss of any on-street parking spaces.

FINANCIAL IMPLICATIONS

Funding of \$70,000 has been allocated to this project for construction in the 2020/2021 Capital Works Program.

PUBLIC CONSULTATION

A letter outlining the proposal was distributed to the affected properties (41 properties) in Donnelly Street, Balmain. One (1) response was received to date, in objection to the proposal. The main concerns are outlined below:


- The balcony, which projects out over the pavement, has previously been damaged by tall trucks. We ask that you please ensure that any changes of road level or profile do not increase the possibility of this happening.
- Proposed speed calming devices will be directly in front of resident's property and concerns of noise generated from accelerating and deaccelerating vehicles has been raised.
- There are too many street signs proposed as part of the works, which would be detrimental to the streetscape.

Council has provided a response in regard to the residents' concerns. These are detailed below:

- Issue regarding road levels will be addressed as part of the detailed design of the project. The road gutter will be raised, and existing stormwater lintel and grate will be upgraded.
- Based on your noise concerns the proposed speed cushion on the northern side of Donnelly Street has been relocated 5m west, as shown in the amended plan.
- The signs that have been proposed are all required in accordance to relevant standards.

SUMMARY

Council received a request from Transit Systems to extend the existing 'Bus Zone' on the southern side of Marion Street, Leichhardt (in front on the Leichhardt Marketplace) to prevent buses from overhanging into the signalised pedestrian crossing at Flood Street and impeding pedestrian movements.

RECOMMENDATION

THAT the existing 5.8m 'Disabled Parking' zone on the southern side of Marion Street, Leichhardt (in front on the Leichhardt Marketplace) be removed and the existing 24.5m 'Bus Zone' be extended to 30.3m in length (extending to the west)

BACKGROUND

Council has received concerns regarding buses overhanging onto the pedestrian crossing (western leg) at the intersection of Marion Street and Flood Street, Leichhardt when an articulated bus or several buses are parked at the existing 'Bus Zone'.

In order to alleviate this issue, it is proposed to remove the existing 5.8m 'Disabled Parking' zone and extend the existing 24.5m 'Bus Zone' on the southern side of Marion Street, Leichhardt (in front on the Leichhardt Marketplace) to the west to a total 30.3m in length as shown on the following plan. This would provide sufficient storage space for two buses.

PUBLIC CONSULTATION

A letter outlining the above proposal was mailed out to the affected properties (20 properties) in Marion Street, Leichhardt, requesting residents' views regarding the proposal. Centre Management of Leichhardt Marketplace have also been consulted.

Two (2) responses from residents were received in objection to the proposal. The main concerns are outlined below.

- Where will Mobility Parking Scheme permit holders park
- Buses will be closer to my house and it is already noisy
- The 'Disabled Parking' zone is used heavily by the Inner West Community ride for seniors.

The following comments are provided in response to the residents' concerns:

- It should be noted that the Leichhardt Marketplace provides 'Disabled Parking' spaces within the complex car park.
- It is not expected that the 5.8m extension of the 'Bus Zone' would have a significant impact regarding noise.
- The Inner West Community buses use the existing 'Bus Zone' and should not be using the 'Disabled Parking' zone.



- Buchanan Street at Robert Street intersection, Balmain (both directions)
- Waragal Avenue at Terry Street intersection, Rozelle (both directions)
- McKell Street at Yeend Street intersection, Birchgrove (both directions)

In addition, the following roads will be closed to all vehicular traffic except State Transit Authority/Transit Systems buses, Taxis, Hire Cars and Balmain Access Permit holders and will be manned by NSW Police officers between 3:00pm Thursday, 31st December 2020 and 12:00am on Friday, 1st January 2021:

- Terry Street at Wellington Street intersection, Rozelle (northbound direction)
- Darling Street at Nelson Street intersection, Rozelle (northbound direction)
- Darling Street at Ewenton Street intersection, Balmain (eastbound direction)
- Evans Street at Merton Street intersection, Rozelle (northbound direction)
- Mullens Street at Robert Street intersection, Rozelle (both directions)
- Ballast Point Road at Lemm Street-Yeend Street intersection, Birchgrove (south and eastbound directions)
- Wharf Road at Grove Street intersection, Birchgrove (eastbound direction)
- Robert Street at Crescent Street, Rozelle (northbound direction)
- Grove Street at Rose Street, Birchgrove (eastbound direction)

The following plan indicates the road closure points.

It should be noted that this year, the NSW Police have requested that right turn movements be restricted into Robert Street from Victoria Road, Rozelle to all vehicles except buses and taxis. NSW Police have requested this restriction to minimise traffic congestion as there have been high volumes of traffic queuing on Victoria Road in previous years. Vehicles wanting to enter the peninsula will now need to continue travelling west on Victoria Road to make a right turn onto Darling Street.

A Traffic Management Plan including Traffic Control Plans outlining the above road closures and the bus route changes is attached in **Attachment 1**.

Taxi Access

As previously recommended, the NSW Taxi Council will again be requested to inform their members of the proposed taxi access restriction after 7pm to minimise traffic congestion in the peninsula and improve pedestrian safety. Taxis will therefore need to use the following drop-off point locations:

- Taxis entering Terry Street In the unrestricted parking on the eastern side of Terry Street or 'Bus Zone' and timed kerbside parking along Wellington Street
- Taxis entering Darling Street In the ticket parking areas along Darling Street and Nelson Street
- Taxis entering Robert Street In the restricted parking area and 'Bus Zone'

Public Transport Access

Transit Systems will be scheduling additional services into the Balmain peninsula to cater for the New Year's Eve celebrations.


As such, temporary 'Bus Zones' will be installed at the following locations:



- Darling Street and the existing 'Bus Zones' on Darling Street between Mort Street and Curtis Road, Balmain
- Eastern side of Grove Street between Wharf Road and Bay Street, Birchgrove

The 'Bus Zones' on Grove Street will be used by Transit Systems and the Police to store buses on New Year's Eve. This is required for the safe bump out of the general public from Birchgrove as identified from a debrief from a previous New Year's Eve event conducted in the Balmain Peninsular.

The signs defining the temporary restrictions be in place after 12 Noon on 31 December 2020 and will be removed the following day.



Based on discussions held in previous years regarding disruptions to bus services leaving Gladstone Park/Curtis Road roundabout due to the gathering of large crowds, the Glebe Police representative introduced Police bike units to manage the crowds in the area.

In addition, to avoid delays that occurred at the Robert Street/Mullens Street intersection (which is a Police check point), buses entering Robert Street from Victoria Road are proposed to use Crescent Street and Parsons Street to access Mullens Street (see TCP 06/07 in **Attachment 1**).

It should be noted that Council will install variable message signs ("Balmain Peninsula is closed" and "Alcohol Free Zone") on the main access roads into Balmain Peninsula a few days in advance of the event;

Temporary 'No Stopping' Restrictions

Following a previous year's event, the Sydney Buses representative advised that several vehicles parked on Montague Street out from the kerb thus narrowing the carriageway and preventing buses from passing each other. Therefore, it is proposed to install temporary 'No Stopping' zone on the eastern side of Montague Street between Darling Street and Beattie Street. The residents will be advised of this arrangement in advance of the event.

Resident Access

To ensure resident access is maintained, the following permits will be accepted for access to the Balmain / Rozelle peninsula:

- Inner West Council Resident Access Permit.
- Inner West Council current Resident Parking Scheme Permit for Areas; B1, B2, B3, B5, BE, BG, R1, R2, R3 & R4.
- Australian Mobility Parking Scheme permit

Alcohol Free Zones

Council has already received approval to re-establish the Alcohol Free Areas for the New Year's Eve celebrations in 2020, 2021 & 2022 at the following locations:

- Illoura Reserve
- 2-8 Weston Street
- Thornton Park
- Lookes Avenue Reserve
- Simmons Point Reserve
- Yurulbin Park
- Birchgrove Park
- Miklouho-Maclay Park
- Mort Bay Park
- College Street playground
- Harris Reserve
- Brownlee Reserves
- Darling Street from Duke Street to Darling Street Wharf
- Darling Street Wharf, Balmain East;
- Lookes Avenue
- Weston Street

These alcohol restrictions are proposed to be in place from 12.00pm (noon) 31 December 2020 to 3.00am 1 January 2021.

Following last year's event minimal feedback was received. However, one issue raised was with illegal parking on Merton Street, Rozelle and the other regarded concerns maintaining

emergency access between Victoria Road and Quirk Street, Rozelle. Both these issues can be addressed through enforcement measures by Council rangers and NSW police.

PUBLIC CONSULTATION

The proposed road closures are currently being advertised on Council's website in accordance with the Roads Act 1993 for a period of 28 days from 17 September 2020 to 16 October 2020. No comments have been received.

In December, the details of these traffic arrangements will be re-advertised on Council's website and via a mail out to all occupants in the Balmain peninsula.

The road closures and other event information will also be available on the Sydney New Year's Eve Event website.

FINANCIAL IMPLICATIONS

Funding for costs associated with New Year's Eve including labour, notifications and permits have been budgeted for in the 2020-21 operational plan.

Introduction

This plan has been prepared on behalf of INNER WEST MUNICIPAL COUNCIL. It has been prepared after discussions with Councils Traffic Engineers and Leichhardt Police. The plan relates to New Year's Eve road closures in Rozelle, Birchgrove, Balmain and Balmain East.

Objective

It is the objective of this report to set out the means and measures by which roads will be closed to through traffic to provide a safe area for the general public to view the New Year's Eve fireworks.

The plan will include a description and detailed plan of the proposed measures, will identify and assess the impact of the proposed measures, will discuss the impact of re-assigned traffic, the proposal's effect on public transport services and what provisions are to be made for Emergency Services vehicles, heavy vehicles, cyclists and pedestrians.

Authority of the TMP

This Traffic Management Plan (TMP) when approved by the relevant authorities becomes the prime document detailing the traffic, transport and pedestrian arrangements under which the Sydney New Year's Eve Fireworks will operate within the Inner West Council area.

In case of emergencies, or for the management of incidents, the NSW Police are not subject to the conditions of this TMP but should endeavour to inform other agencies of the nature of the incident and the Police response.

7. Assessment of public transport services affected

- State Transit Authority (STA) and Transit Systems will operate services to a special New Year's Eve timetable increasing services to all routes servicing vantage points.

SUMMARY

Council has finalised a design plan for the proposed continuous footpath treatment on Watson Lane at the intersection of Booth Street, Balmain. The intention of the proposal is to address concerns about pedestrian safety and driver behavior in the area by slowing traffic and prioritising pedestrians crossing Watsons Lane.

RECOMMENDATION

THAT the detailed design plan (Design Plan No.10145) for the proposed continuous footpath treatment on Watson Lane at the intersection of Booth Street, Balmain be approved.

BACKGROUND & OTHER STAFF COMMENTS

The detailed design plan shown in **Attachment 1** outlines the proposed works on Watson Lane at Booth Street, Balmain and includes the following treatments:

- Removal of existing kerb ramps and asphalt footpaths in Booth Street on both sides of Watsons Lane and replacing with new concrete footpath
- Constructing a raised threshold across Watsons Lane, incorporating a new concrete footpath
- Removing existing sandstone kerb in Booth Street and resetting along new alignment with new concrete gutter
- Providing new landscaped verges within the widened footpath in Booth Street
- Installing associated line marking (as shown on plans).

The proposal will not result in the loss of any on-street parking spaces.

FINANCIAL IMPLICATIONS


Funding of \$50,000 has been allocated to this project for construction in the 2020/2021 Capital Works Program.


PUBLIC CONSULTATION

SUMMARY

Council has received an application from a resident for approval of a temporary full road closure of Red Lion Street, between Darling Street and Evans Street, Rozelle on Saturday, 19 December 2020 from 6:00pm – 12:00midnight.

RECOMMENDATION

THAT the proposed temporary full road closure of Red Lion Street, Rozelle between Darling Street and Evans Street on Saturday, 19 December 2020 between 6:00pm and 12:00midnight be APPROVED, in order to hold a street party, subject to the conditions of approval as set out in the Street Party Application Form and the following conditions:

- 1. Latest government and health advice on Covid-19 is followed at the time of the event including gatherings and/or social distancing restrictions;
- 2. All affected residents and businesses, including the NSW Police Area Command, Fire & Rescue NSW and NSW Ambulance Services be notified in writing, by the applicant, of the proposed temporary road closure at least 14 days in advance of the closure with the applicant making reasonable provision for stakeholders;
- 3. The applicant is to set out the road closure as per the attached typical Traffic Control Plan (TCP) and a 4-metre wide emergency vehicle access be maintained through the closed road areas during the course of the event; and
- 4. The occupation of the road carriageway must not occur until the road has been physically closed.


BACKGROUND & OTHER STAFF COMMENTS

The Red Lion Street party is an annual event and no significant issues have occurred in the past (first event was in 2009).

Council encourages properly conducted neighbourhood street parties as a means of building community spirit and improving neighbourhood security. Fees for road occupancy are waived by Council for small community street parties. For approved street parties and subject to availability Council will provide barricades and 'Road Closed' signs subject to the street party coordinator arranging collection from and return to Council's depot.

According to the RMS 'Guide to Traffic and Transport Management for Special Events' a small street party is considered as a 'Class 3' event. Impacts of the road closure for the event are considered minimal. Vehicular access for residents/businesses is to be maintained during the closure, where possible. A typical 'standard' Traffic Control Plan (TCP) for the Closure is reproduced below.




